Continued: Mass DEP File #263-1158: Notice of Intent application for the use of hydro-rakes and aquatic herbicides/algaecides to manage aquatic nuisance vegetation on property located at 669 Churchill Street in Pittsfield (Map D13, Block 2, Lot 2.) Such actions are proposed to occur within Inland Bank and Land under Waterbody. The applicant is Jeffrey Carr.
- B. Continued: Mass DEP File #263-1172: Notice of Intent application for the removal of nuisance aquatic vegetation on property located at 639 South St/Country Club of Pittsfield (Map H4, Block 2, Lot 1.) Such activities are proposed to occur within Land Under Waterbodies. The applicant is the Country Club of Pittsfield.
- C. Continued: Mass DEP File #263-1173: Notice of Intent application for improvements to an existing outdoor athletic facility, and beach nourishment, on property located at 195 Cloverdale Street (Map C2, Block 1, Lot 1.)
